Scope and Contents

The Frank E. Smith collection, retained in original order, is comprised of four series:

1. Frank E. Smith TVA Speeches
2. The Southern Regional Council and Voter Education Project
3. Conservation History
4. Books and other publications

The Frank E. Smith TVA Speeches series, 1962-1972, consists of speeches made by Smith while serving as director of TVA and clippings, press releases, brochures, etc. Also included are notes from Smith's secretary re: the speaking engagements and newspapers re TVA's 30th anniversary (5/18/1963). Folder 119 contains a tape recording made by Mr. Smith - "Thirty-five Years of TVA". Folders 193 and 194 contain speech material such as TVA background material, basic facts about TVA and TVA newsletters. Books and publications concerning TVA are listed with the general bibliography at the end of the description. Five manuscript boxes not including volumes.

The Southern Regional Council and Voter Education Project series, 1963-1972, contains correspondence, annual reports, audit reports, special reports, memos, minutes of meetings, biographical material, publications (scattered issues of New South), press releases, etc. See the general bibliography for books and publications. Two manuscript boxes.

The Conservation History series contains correspondence with Van Nostrand Reinhold Company and Chelsea House Publishers, correspondence with the editors of other volumes of the series, other correspondence; publicity material; reviews; outlines of the series; typed manuscripts and galley proofs; documents used in the preparation of the Land and Water volumes and documents collected but not used. This series is in part copies (circa 20%). Books and other publications concerning conservation are listed in the bibliography. Six manuscript boxes.

The Books and other publications pertain mostly to the three series already described. Because of the overlap of subject matter, all were placed at the end of the collection except a few publications which were already in folders in the above series. This series was divided in the following manner:

1. Books kept with the collection - other copies available in library
2. Publications other than books - other copies available in library
3. U. S. Government documents
4. Other publications - not available in library but kept with collection
5. Scattered issues of serials not available in library
6. Books not available in library.
